FOIA Request Procedures:

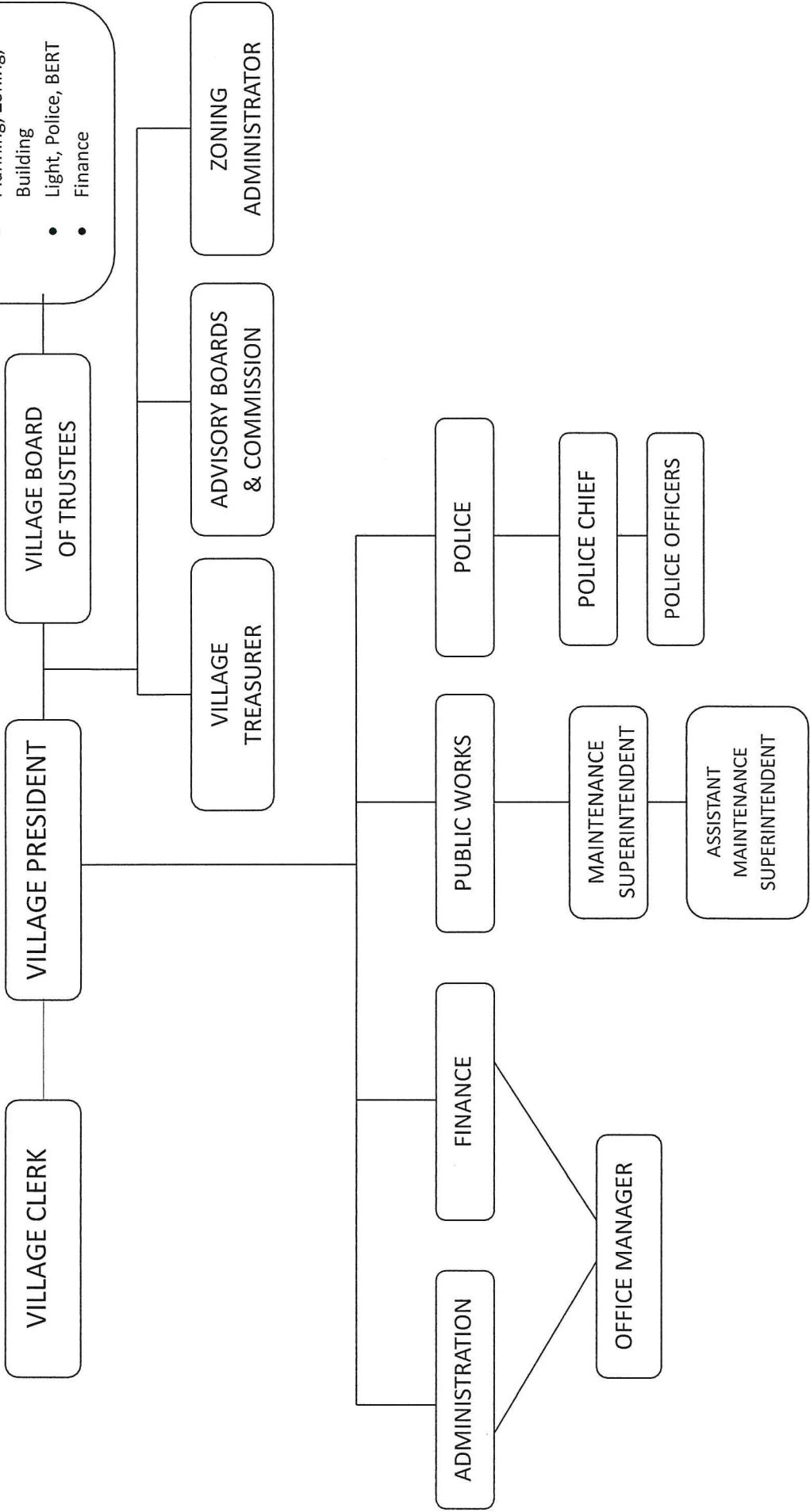
The Village has a form which can be filled out if you wish to request information and public records. All requests shall be made in writing. See attached form.
